REPORT OF THE COMMITTEE

TO THE MEMBERS, ROYAL SOUTH YARRA LAWN TENNIS CLUB

The Committee presents the accounts of the Club for the year ended 30 June 2015, and reports to you on the affairs of the Club for this period.

The General Committee

Sally Charles and Amanda Schwilk were elected to the General Committee at the November 2014 Annual General Meeting, and Tony Joubert (Captain), Lachie Beer and Di Hepworth were re-elected. John Dixon and Alec White resigned from their positions, and we thank them for their service to the Club.

Your Committee again had a constructive year, and we outline in the following report some of the key undertakings, as well as the more substantive sporting and social activities.

Financial

In summary the Club has had a successful year and is in a sound financial position. A positive operating cash flow of \$819,000 continued the trend of strong cash inflows. We note that the depreciation expense will further decrease in the coming year, reducing from \$691,000 in 2015 to \$575,000 in 2016.

Capital Works

We continued to re-invest in Club facilities with the major items of capital expense during the year including the replacement of the air-conditioning systems to the Members' Restaurant, Como and Norman Brookes Rooms, renovation of Mont Verdant apartments 3 & 4, introduction of LED lighting to porous courts 1-4, complete renovation of porous courts 1 & 2, and re-surfacing of porous courts 5-7. We plan further court renovation work to porous courts 3 & 4 in the coming year.

Membership

Membership numbers have been maintained (see separate report) and we continue to work on various initiatives to streamline the membership nomination and approval processes. It was pleasing to see high levels of member participation during the year in a wide variety of sporting, recreational and social events.

Squash Teams

The Club continued to field a number of Men's Squash teams with some success (the B3 & B4 teams both won pennants in the spring 2014 season, and the D3 team won their pennant in the autumn 2015 season - see separate report). Our Club Squash Championships attracted a good field and were very well contested. We also introduced our inaugural RSYLTC/ Royal Melbourne Tennis Club Handicap Squash tournament in February, with good participation and this was enjoyed by all.

Tennis

Please see the detailed separate report, however some of the main achievements follow:

We continued to hold our Club Championships in a combined juniors and seniors format in February, and we consider this structure creates a vibrant atmosphere. The Championships were strongly contested with all participants enjoying the competition.

In 2015, the Club again fielded a good number of winter Tennis Victoria pennant teams (nine Men's and eight Ladies'). We fielded ten teams in the Blackburn night competition, seven in the mid-week Eastern Districts Women's Tennis Association, and one Bayside competition team.

In the past year we fielded a Men's Asia Pacific Tennis League team, which finished 3rd in their final at Melbourne Park during the Australian Open. We also provided both a Men's and Women's team in the 2015 Premier League competition.

The intra-club Captain's Trophy was conducted for a second year, with a wide field of entries for both Singles and Mixed Doubles. This event is proving increasingly popular.

RSY entered eight teams for the 2014 spring Junior Competition season with our Saturday Section 2 team winning the premiership. The Club offers a Tuesday night and Friday night training squad for our junior teams, which are tutored by our Head Tennis Coaches.

The Club has continued its contract with SMARTennis for the provision of coaching services. This service works well for members and we thank the coaching team for their enthusiasm and commitment to their various undertakings, including our Hot Shots program. Hot Shots in particular has proved very successful, where we have close to 100 children enrolled. Due to its popularity, the Club has run a Hot Shots inter & intra Club Competition which commenced in T1 of 2014 and this has been offered and run each term since. RSY has fielded at least three teams in each term since the inaugural competition commenced.

We also hosted the Foundation Cup for interstate Under 13 players for a second year in January. Tennis visits away during the year included our annual challenge against the Royal Sydney Golf Club held in Sydney in November, as well as an inaugural 'quadrangular challenge' at the invitation of the All England Lawn Tennis and Croquet Club at Wimbledon in May, which was thoroughly enjoyed by those lucky enough to participate.

Fitness Classes

The breadth of fitness class offerings continued to expand further during the year. We now offer a record number of classes, and have many more members participating than in previous years. We were also fortunate to secure the services of Jarah Breese, a highly qualified new personal trainer.

Awards

Mary Church was presented with the RSY Foundation Distinguished Service Award for outstanding service to the Club at the November 2014 Annual General Meeting. In addition, Jennifer Langford was awarded the Nick Reid Service Award for outstanding service by a younger member.

Crèche

We continued to operate 3 sessions daily on weekdays at our crèche and this service is well appreciated, allowing members to play tennis, attend fitness classes or just enjoy hospitality around the clubhouse.

Strategic Planning

Work continued in implementing the initiatives set out in our 2012-2016 Strategic Plan. As the majority of actions have been completed, the main initiative now being progressed is the development of our Site Master Plan, with the working group being chaired by the Hon. Secretary.

Communications

The Committee and Administration team continued its focus of developing our primary communication channels with members. We were excited to launch our completely redeveloped website during the year. Our new website delivers a modern responsive structure, greater ease of navigation, and provides much more interactivity in effective communication. The website can be readily viewed on any size device or screen and is proving an invaluable resource for the Club and its members.

We also commenced engagement in social media this year, creating Facebook, Instagram, Twitter and YouTube accounts. The social media platforms provide us with powerful resources to keep our members up to date with timely posts of news, happenings and events. With a growing following on all these accounts, we now have a positive social media presence, with members enjoying the frequent updates.

Other regular avenues of communication to members include the fortnightly 'RSY Happenings' emails, which keep members informed on all current events or announcements. At a more strategic and policy level, the 'President's Pen' email, sent out every two months, recaps any key issues that have arisen and reminds of any forthcoming major events or significant developments.

Centrecourt magazine continues to be issued twice yearly in both e-mag format and hard copy (upon request), and is always popular with members, providing interesting reports and glossy photos covering all aspects of the Club's activities.

House Activities

The House Allowance continued to be strongly supported, contributing to the increased usage of the hospitality facilities and the overall buzz around the clubhouse. We do note that there is a small retention of unused allowance at the end of the year, as there was last year, and we encourage members to ensure they fully expend this allowance.

Our Christmas Cocktail Party was well supported in December with over 170 attending the night.

Following on from last year's 130th anniversary party, the Club held its very popular Grand Aperitivo 'farewell to summer' cocktail party in March, with over 200 attendees. Highlights included wonderful champagne, the varied food stations, good companionship and the 20 minutes of fireworks! All enjoyed the evening immensely.

Our 15th Vintage Lunch on the last weekend of the Club Championships in February proved popular also, with over 100 attending. Our thanks to Susie Strangward for convening this event once again.

Various other events have included the Winemakers' lunches and dinner, the President's Tennis Day, the President's vs. Captain's Tennis Day, and our Anzac Day commemorative parade and lunch (with a very evocative talk by member Peter Isaacson).

Our Younger Members' events have included the combined Yarrayong Ball (held at RSY this year), barefoot bowls, a Younger Members footy night, and 'Tennis and Tonic' tennis nights.

The RSY Bridge group continues to thrive and held many events during the year. New members are always welcome.

Reciprocal Clubs

The Kelvin Grove Club in Capetown and the British Club in Bangkok were added to our select list of reciprocal clubs during the year, and we hope members enjoy the benefits of these arrangements.

External Relations

We have continued to strengthen our relationship with Tennis Victoria and Stonnington Council over the past year. These relationships are mutually important and we will continue to foster them.

RSY Foundation

Janie Bell, Phillip Gray and Cathy Moore were appointed as trustees of the RSY Foundation during the year, replacing Peter Clarke and Susie Strangward (whose service over many years is much appreciated). Numerous donations to the Foundation were made during the year following a reinvigoration of the Trustees' approach. Again, please see the separate report in relation to the Foundation.

Members' Carpark Boom Gate

As members will be aware, Stonnington Council disappointingly has required the disablement of the boom gate and refused our application for the requisite Planning Permit amendment. The Club is appealing this decision at VCAT.

Staff And Sub-Committees

We welcomed Sam Dove (Events Manager) and Andrew Serong (Business Development Manager) during the year. Also Jessica Trewin returned to the Club's staff in the new role of Sport & Communications Manager.

The Committee would like to thank all of our staff, particularly our General Manager, Kim Young and his senior management team, for their work this financial year. We would also like to thank all sub-committees for the work they have done during the year, particularly as their participation is pivotal to the Club's on-going success.

building a corpus to future proof the Club. It will allow us to continually improve our world class facilities and help protect us against unforeseen events.

Funds from the Foundation will be directed towards sport development and capital projects, as nominated by donors. The Trustees are considering establishing a sport development bursary for elite tennis or squash players and supporting capital projects identified within a RSY Master Plan framework, currently being prepared.

At the 2014 AGM the Foundation Chairman presented its Distinguished Service Award to Mary Church.

SPORTS

Tennis

The Captain's Committee continued to implement many of the objectives outlined in the Strategic Plan which will lay a strong foundation for further growth and activity at the Club.

We are fortunate as a Club to have a Captain's Committee so full of energy to boost the strength and depth of the Club's numerous sporting teams and events. The Sports Director, Jarrad Wright has become an integral part of our tennis and sporting programs and assists greatly with participation in all events, competitions and sporting activities.

The Club fielded teams in the Asia-Pacific Tennis League, Tennis Victoria Premier League and winter pennant. We also submitted teams in the Eastern Districts Women's Tennis Association, the Blackburn & Districts Night Tennis Competition, Bayside Junior Competition, Bayside Regional Summer Competition and the Squash Club Circuit.

While there are many areas to address, particular attention has been focused on the following:

- An increase in standard of the junior tennis programs activities, Hot Shots, training squads and competitions;
- Increased participation at all levels of competition and social tennis and other sporting, fitness and social activities; and
- A stronger rapport between the Club and the wider tennis community.

The Club fielded both women's and men's pennant teams in almost every grade and the Night Competition was increased to three evenings. At a social level, the Club continued to promote organised social tennis which provides an opportunity for players of all standards to meet other Club members and play in a relaxed atmosphere.

Pennant Tennis

The Club entered 22 teams in men's and women's 2014 Tennis Victoria Pennant competition. It was a successful year with three men's teams and five women's teams qualifying for the finals – the Women's Grade 2(2), Men's Grade 4(2) and Men's Grade 7(2) reached the grade finals and the Men's Grade 1(2), Women's Grade 2(2), Women's Grade 3(1), Women's Grade 5(1) and Women's Grade 6(2) reached the sectional finals.

The RSY Sports Dinner was held in August with 122 members and guests attending. This dinner recognises sporting achievements and is a celebration of all competitive sports at the Club. Cedric Mason was the Master of Ceremonies, a video was shown of 'Our Club-Then & Now' and the evening featured Club member, Peter Johnston as guest speaker and Greg Champion from the 'Coodabeen Champions'.

The winner of the Warren Kennedy Memorial Trophy was Lloyd Havlik. This trophy is awarded annually to the best performing men's pennant player. The Ethel Le Neveu Trophy, awarded to the best performing women's pennant player, was won by Gussie O'Sullivan.

The Judy Dalton Trophy for the best performance in Mid-Week Ladies competition over two seasons was won by Miranda Lansell and Jacqui Nelson. The Dick Doyle Memorial Trophy for the best performance over two squash seasons was won by David Fabinyi. The Night Tennis Perpetual Trophy was won by James Joseph and the Junior Trophy for the best performance by a member 16 years of age and under was won by Annabelle Hicks.

Asia - Pacific Tennis League (ATL)

The ATL commenced in November with the RSY Royals men's team finishing runners-up to Kooyong Lawn Tennis Club in the South East Conference. We advanced to the National playoffs which are held at Melbourne Park during the Australian Open. RSY finished in third place in the Asia-Pacific Tennis League tournament, with the Tennis Brisbane Chargers winning the title.

The RSY Royals men's team consisted of Luke Saville, Alex Bolt, John-Patrick Smith, Dane Propoggia, Adam Hubble, Jeremy Beale and Lewis Miles.

Premier League

The Tennis Victoria Premier League was held during March and April, showcasing the best tennis in the State. This competition features five rounds of tennis; each Club hosts a round with all matches at the one venue.

Royal South Yarra entered a men's and women's team in the Premier League competition. The men's team was very competitive reaching the semi-final, losing to Kooyong Lawn Tennis Club. Grace Park Lawn Tennis Club won the men's competition. The women's team consisted of younger players who were competitive and enjoyed the experience but did not qualify for the finals. Beaumaris Lawn Tennis Club won the ladies competition.

The men's team consisted of Aaron Leeder-Chard, Lewis Miles, Jeremy Beale, Matthew Leffler, Harry Lim, Alexandros Yiappos, Yuri Mijic and Conrad Lim.

Mid-Week Competition

Summer Competition

The Club entered one team in the Bayside Regional summer competition. The Ladies Section 2 team was captained by Kate MacNeil and the team competed admirably and enjoyed tennis of a high standard.

Night Competition

The Club submitted eight teams in the spring competition and nine teams in the autumn competition of the Blackburn & District Night Tennis Association.

Four teams reached the semi-finals in the spring competition. In the Monday night competition the Open Section 4 What a Racquet team consisting of Fiona Ralph (Captain), Sally Charles, Zoe Browning, Richard Charles, Sophie Richards, Fiona Murdoch and Richard Ralph and the Ladies Section 2 Top Shots team of Sarah Robinson (Captain), Eliza Robinson, Belinda Henry, Sue Gatford, Brigitte Claney, Charlotte Fenner, Margaret Neeson, Jacqui Saunders and Bernadette Stephen won their grand final. Club Championships

In February the senior and junior Club Championships were held to determine the best competitors in each tennis category; including those competing for the prestigious Honour Board events. The standard of tennis was high which demonstrates the depth of talent developing at the Club. There were new champions in both the Men's and Ladies Open Singles events. Junior Tennis

The Junior Tennis Sub-Committee ran a variety of events during the year which focused on inclusion and improving the standard of junior tennis. We attempt to run events aimed at bringing junior members together to enjoy the Club, as well as providing adequate opportunities for juniors to engage in competitive events.

During the year there were ten events which included two seasons of junior competition in the Bayside Regional Tennis Association, the continuation of our involvement in the Tennis Victoria Hot Shots program, two Junior Round Robin Tournaments, the Teen Tennis Challenge, the Adult & Child Tennis Day, Junior Open Day, Junior Club Championships and the Year 8 Disco.

In the spring competition of the Bayside Regional Tennis Association (BRTA) one team competed in the Saturday competition and seven teams competed in the Sunday competition. The Saturday Section 2 team consisting of Giselle Lansell, Hamish Francis (Capt.), Sam McLean, Freddie Campbell, Lucy Campbell, Annabel Joubert, Tom Bartlett and Lachlan Mailer won the grand final and the Sunday Section 2 team captained by Liam Albrecht reached the finals. In the autumn competition, two teams competed in the Saturday competition and seven teams competed in the Sunday competition. The Saturday Section 2 team captained by Maxim Fisher finished runners-up and the Sunday Section 2 team captained by Chloe Joubert reached the finals.

Training for the BRTA competition is held on a Tuesday evening and squad training for the more advanced players is held on a Friday evening. A variety of formats continued to be trialled to ensure these sessions are valuable to players and as a consequence improve attendance.

The Tennis Victoria Orange Ball Hot Shots competition for children 10 years and under continued throughout the year. The development of the Hot Shots program remains a key program to increase the participation of juniors playing tennis at the Club. The program is a variation of tennis for younger children on smaller courts, using lighter racquets and low-compression balls that don't bounce as high as full compression balls, making learning tennis fun and easy for children, and allowing them to start rallying much earlier in the sport. A Junior Round Robin Tournament was held in August and May. These tournaments remain a good way for junior members to get involved with tennis and meet other members.

In November we held the Adult and Child Tennis Day. The purpose of this day is to allow junior members to play with a parent, grandparent or family friend in an atmosphere where they can learn the rules and etiquette of the game as well as learning to play with adults and socialize after play at a barbecue.

In February, the Junior Club Championships were held in conjunction with the Senior Club Championships. This combined format was in its third year and continues to be successful, with around 60 junior members playing in the championships. The events included 10/U, 12/U, 14/U, 16/U singles and doubles, open boys and girls singles, and 14/U and 16/U mixed doubles events.

The Junior Open Day held in March is an event which provides junior members with an opportunity to understand more about the tennis side of the Club and enjoy a full afternoon of grass court tennis with their friends. On this day we also welcome children who may not have played much tennis or been involved with the Club. The most prestigious junior award, being the Stan Churchus Trophy, is also awarded on this day. This trophy is awarded to a junior member who has regularly represented the Club in competition tennis, shown good commitment to Club events and demonstrated good sportsmanship and demeanour over an extended period. This year the trophy was awarded to Harry Veall.

The Year 8 disco was held in May and the evening was well attended with 200 members and guests enjoying a fun and well organised event.

The development of juniors is the key to the future success of tennis at the Club. Clearly with around 500 junior members and only a comparatively small number playing tennis regularly there is significant opportunity for development. We are always on the lookout for ways of increasing junior participation and events that will be attractive to junior members.

During the year Kate Beggs and Louise Field were welcomed to the Sub-Committee.

Tennis Coaching

The tennis coaching provided by the committed and qualified professional coaches from SMARTennis continues to be very beneficial to the Club.

Head Coaches Andrew McLean and Conrad Lim and their coaching team provide a high quality service to meet the tennis needs of all members. Throughout the year the coaches implemented fitness squads, tactics sessions and tennis skills whilst continuing to offer private tuition, group lessons, holiday programs, clinics, a boot camp cardio tennis program, squad training, the Hot Shots program and country tournaments for members' participation.

During the year members of the coaching team represented the Club in Tennis Victoria Premier League and pennant tennis.

SMARTennis are an integral part of the Club and play a valuable role in supporting senior and junior tennis.

Squash

The Club fielded four teams in the spring and autumn competition of the Squash Club Circuit. Grades B3, C2, D2 and F competed in the spring competition and Grades B2, C2, D3 and F competed in the autumn competition.

In the spring competition the B3 team consisting of Jim Woods, John O'Sullivan, Rob Warnock, Jonathan Cameron and Trevor Giacometti (Capt.) won the premiership defeating the Bentleigh Club. In the autumn competition the D3 team of Rollo Morgan, Charlie Lie (Capt.), Richard Campbell, James Anders and Will Yencken also won the premiership defeating the Bentleigh Club.

The Squash Club Championships saw a new Men's Open champion Jason Wolff, who defeated defending champion James Kavourakis. Sophie Temple retained the Women's Open title defeating Sophie Trotter and John O'Sullivan retained the Handicap title defeating Rob Warnock.

The inaugural Royal South Yarra v Royal Melbourne Tennis Club inter-club handicap competition was held at Royal South Yarra in February. In an all RSY final Jonathan Cameron defeated David Court.

Table Tennis

The 17th Table Tennis Club Championships were held in October, with 30 players participating in a knockout draw in the Men's and Women's Singles, Men's Doubles and Mixed Doubles events.

In the Women's Singles final Marie Monterosso defeated Jovana Stanisic. The Men's Singles was won by Andrew Spargo who defeated Edward Bickford. Indoor Sports & Fitness

There is a wide range of indoor sports and fitness options available to members. The very popular swimming pool continues to attract members who enjoy lap and leisure swimming, swimming lessons and aqua aerobics. The state of the art gymnasium enjoys fantastic views over the grass tennis courts and during the year new equipment was introduced in the free weights room. Experienced Personal Trainers were appointed to the fitness area and during the year the Sports Director scheduled new fitness classes to meet the needs of members, with the majority of classes held in the Fitness Studio. The indoor sporting facilities are an integral part of the Club's offering and are highly valued by members.

ACTIVITIES & REPORTS

Activities & Communication

Clubhouse patronage has been very strong with good support from members.

With all regular Club events such as the First Saturday in the month BYO dining, Last Friday in the month drinks, Father's Day and Mother's Day celebrations attracting good numbers, it is pleasing to see a consistent pattern of members using the clubhouse services.

The spring wine appreciation lunch was held in October and featured Scott Wasley, Australia's largest importer of fine wines from the regions of Spain. Also in October we held the ever popular black tie dinner of the Caulfield Cup Calcutta for racing aficionados. December heralded the Christmas Party drinks on the Balcony complete with carol singers for over a hundred guests. In February we conducted the social Tennis and Guest Day for sixty eager players which concluded on a very hot evening with a casual barbecue adjacent to court 1 with tables festooned with fairy lights. The Grand Aperitivo Cocktail Party in March was a Club highlight where members and guests were treated to chef-attended food stations and a stunning fireworks display. In May we held the autumn wine appreciation lunch featuring winemakers from the Mornington Peninsula Wineries End of Harvest Lunch and again Head Chef Peter Villinger excelled in preparing magnificent fare to accompany the wines of the participating winemakers; Tim Elphick: Portsea Estate, Kathleen Quealy: Quealy, Michael Lee: Foxeys Hangout and Ewan Campbell: Phaedrus Estate.

Our sincere thanks and admiration must go to the contributions and efforts of the Club's hospitality and administrative staff in providing excellent service to all members.

Centrecourt, the President's Pen, emag, emails, the new informative and user friendly website together with the recently introduced social media platforms of Facebook, Twitter and Instagram ensure that the Club is abreast of current day communication tools.

To keep the membership informed we request that all members strive to keep their phone number, mailing and email addresses up-to-date, as they are the mainstay for Club communications. You can advise the Club administration or update your details on the website should the need arise.

We have continued to maintain good relationships with external organisations such as Tennis Victoria, Kooyong Lawn Tennis Club, the West Brighton Club and Royal Melbourne Tennis Club. These relationships are important to us and we will continue to strengthen them. We also seek to develop closer ties with Stonnington Council.

In the last financial year we introduced two new reciprocal clubs - The Kelvin Grove Club in Capetown and the British Club in Bangkok. Royal South Yarra is also a member of the Association of Centenary Tennis Clubs boasting some of the most prestigious clubs in the sport. During the year members have continued to enjoy reciprocity opportunities and relationships with both our existing reciprocal clubs and the Centenary Tennis Clubs.

A key aim is to develop more effective communications for members through the website to ensure features such as terms and conditions of reciprocal clubs are well known.

We continue to expand the list of reciprocal clubs which appeal to members and are always grateful for members' feedback on clubs they have visited.

Clubhouse & Grounds

The clubhouse and activity throughout the club grounds has been particularly vibrant this year.

The grass courts continued to be in excellent condition over the year. It was a slightly longer grass court season due to the warmer weather in the summer months. Bill Turner and his staff continued to maintain an excellent playing surface culminating at their peak during the Club Championship weekends in February.

The improvement of our porous courts was undertaken over the year. The full rebuild of porous courts 1-2 is now complete. It did take some months for the surface to be fully compacted, and playing conditions now are excellent. Court drainage on these two courts has also significantly improved. At the completion of the winter pennant season works will commence on the rebuild of porous courts 3-4, and it is envisaged it will take approximately five months until they will be back playing at their optimum.

The new LED lighting of porous courts 1-4 has also been successful. On-court lighting has significantly improved and ongoing lighting and maintenance costs have reduced.

The Committee continues to review alternatives to replace the Cypress hedging behind porous courts 5–7. The brief also incorporates upgrading the bathroom facilities behind grass court 10, the pathways leading from the clubhouse up to porous courts 5-7 and landscaping around that general area. Landscape architects have been appointed and have drafted initial concept drawings. This will be a major project and consultation with members will be part of the process.

The Mont Verdant apartments have again been very popular with very high occupancy rates again this year. The renovations of apartments 3 and 4 have been very successful, significantly upgrading the original facilities. Apartments 1 and 2 will undergo the same upgrade this financial year.

We thank Bill Turner, Wayne Cuebas, Anthony Lewis, Kevin Terry, Dominic Lavecchia and Andrew Donald who have all made a great contribution and are very much appreciated.

Young Members

The Young Members have enjoyed a great year which has seen many popular annual events staged. These included: Barefoot Bowls in November on the grass courts (which encompassed the Turning 18 drinks), summer Friday Night Drinks on the balcony in front of the Tennis Club Championships in February, 'Tennis & Tonic' social tennis evening in May and the signature event of the year, the Yarrayong Ball was held in August. We joined forces with Kooyong Lawn Tennis Club Young Members in the Como Room for the annual Yarrayong Ball. It was a mysterious night of masquerade and allure with a sell-out attendance by young members and guests dressed to kill!

The committee is continually looking to grow the involvement of the young members for the Club's social events and always looking for new and refreshing ideas for the calendar.

Sunday Morning Group

The Sunday Morning Group continues to thrive, with Sunday morning Men's Doubles Social tennis available for Playing Gentlemen. The morning commences at 9:00am irrespective of weather conditions throughout the year.

All adult Playing Gentlemen of any age are welcome to participate, with many taking the opportunity to meet and mix with fellow members. Social tennis is the standard and there is no commitment to attend. Members may play when they wish during the morning and for as many sets as they wish. The emphasis is on good sport, good fellowship and enjoyable exercise.

Tuesday Tennis

The Tuesday Tennis Group meets in the Pavilion at 9:15am for 2-3 sets of social tennis. The morning concludes at approximately 11:45am, when players can stay for a light lunch in the clubhouse or make a day of it with lunch followed by bridge in the afternoon.

During the year, six Tennis Badge Day tournaments are conducted for members who enjoy a little more competition, competing for the Joy Fair - Ladies Day Perpetual Trophy. In December, the winners and runners-up of the two sections play off in a final, culminating with the overall winners in each section announced at the Christmas lunch.

TREASURER'S REPORT

The Club's financial position remains strong, with an ungeared balance sheet and improving cash flows, underpinned by our loyal membership base. Total revenue increased by 5.2% to \$7.08 million in 2015, and operating costs rose by 2.1% to \$7.23 million. The Club's overall deficit of \$152,911 was an improvement of \$202,504 compared with 2014, and was recorded after a (non-cash) depreciation charge of \$690,947.

Hospitality

The Club has invested in our entertainment and dining areas over recent years, and it was pleasing that activity levels in the members dining and bar areas remained high throughout 2015. Hospitality revenues were the highest in the Club's history, at \$2.84 million, an increase of 5.1%. Further investment in service levels were made, and wages increased as a consequence, leading to a slight increase in the Hospitality loss for the year. The Club expects a further improvement in Hospitality results, and will continue to balance the objective of strong financial performance with the need to ensure that members enjoy a strong value proposition for their subscriptions.

Capital Expenditure

A key objective of the Club is to further improve the standard of our facilities, as we seek to build upon our position in a very competitive leisure and entertainment market. The Club more than doubled capital expenditures in 2015, to \$485,295. Major items included the renovation of Mont Verdant units 3 & 4 (\$147,053), Air conditioning for the Como Room & Norman Brookes Room (\$92,898), IT upgrades: our new website, extended wifi and new computers (\$91,717); the redevelopment of porous Courts 1,2,5,6 & 7 (\$46,590); and LED lights for Courts 1–4 (\$33,400).

Finance Committee

I would like to thank Ian Jarman, Hamish Salmon and Chris Yencken for their contribution to the Club and their valuable input into the Finance Committee.

Principal Activities and Objectives

During the financial year, the principal activities of the Club, which remained unchanged, were the provision of sporting and clubhouse facilities and member accommodation. The Club's focus is on the development of tennis and increased member participation. Interclub competitions, round robins, social events and junior activity days aim to increase participation both short term and long term.

Operating Results

Results for the year were a much reduced operating loss of \$152,911 (2014: loss \$355,415)

Review of Operations

The continued support of Members dining at the Club helped increase Hospitality Revenues to \$2,844,228 (2014: \$2,706,367). This report discloses that the cash flows from operating activities resulted in a net cash inflow of \$819,059 (2014: \$582,279) and cash of \$483,230 (2014: \$202,910) was invested in Intangible Assets, Property, Plant and Equipment.

Significant Changes in the State of Affairs

Apart from the foregoing, no significant change in the Club's state of affairs occurred during the financial year.

Subsequent Events

No matter or circumstance has arisen since the end of the financial year which has or may significantly affect the operations of the Club, the results of those operations or the state of affairs of the Club in future financial years.

Dividends

The Club's memorandum of association prohibits the payment of dividends.

Future Developments

No change in the operations of the Club is expected to occur which will, or may, affect the results of the Club in the next succeeding financial year.

Member Liability

The Club is a company limited by guarantee. If the Club is wound up, the Articles of Association state each member (all classes) is required to contribute a maximum of \$8.40 each towards meeting any outstanding liabilities of the Club. As at 30 June 2015, the number of members were 4,475 (2014: 4,498).

Environmental Issues

The Club's operations are not regulated by any significant environmental regulation under a law of the Commonwealth of Australia or of any State or Territory.

1. General information & Statement of compliance

The financial report is a general purpose financial report that has been prepared in accordance with the Corporations Act 2001, Accounting Standards and Interpretations, and complies with other requirements of the law.

Accounting Standards include Australian equivalents to International Financial Reporting Standards ('A-IFRS'). Royal South Yarra Lawn Tennis Club (RSYLTC) complies with all Australian equivalents to A-IFRS in their entirety as applicable to not-for-profit entities.

In the current year, the Club has adopted all of the new and revised Standards and Interpretations issued by the Australian Accounting Standards Board (the AASB) that are relevant to its operations and effective for the current annual reporting period. The financial report was authorised for issue by the Committee on 22 September, 2015.

Royal South Yarra Lawn Tennis Club is a company limited by guarantee, incorporated and domiciled in Australia.

2. Adoption of new and revised Accounting Standards

2.1 New and revised AASBs affecting amounts reported and/or disclosures in the financial statements

In the current year, the Club has applied a number of amendments to AASBs and a new Interpretation issued by the Australian Accounting Standards Board (AASB) that are mandatorily effective for an accounting period that begins on or after 1 July 2014, and therefore relevant for the current year end.

STANDARDS AFFECTING PRESENTATION AND DISCLOSURE

AASB 2012-3 'Amendments to Australian Accounting Standards – Offsetting Financial Assets and Financial Liabilities'

The amendments to AASB 132 clarify the requirements relating to the offset of financial assets and financial liabilities. Specifically, the amendments clarify the meaning of 'currently has a legally enforceable right of set-off' and simultaneous realisation and settlement'.

This standard has not had any impact on the financial statements.

AASB 2014-1 'Amendments to Australian Accounting Standards' (Part A: Annual Improvements 2010–2012 and 2011–2013 Cycles)

The Annual Improvements 2010-2012 has made number of amendments to various AASBs, which are summarised below.

- The amendments to AASB 2 (i) change the definitions of 'vesting condition' and 'market condition'; and (ii) add definitions for 'performance condition' and 'service condition' which were previously included within the definition of 'vesting condition'. The amendments to AASB 2 are effective for sharebased payment transactions for which the grant date is on or after 1 July 2014.

The amendments to AASB 3 are effective for business combinations for which the acquisition date is on or after 1 July 2014.
- The amendments to the basis for conclusions of AASB 13 clarify that the issue of AASB 13 and consequential amendments to AASB 139 and AASB 9 did not remove the ability to measure short-term receivables and payables with no stated interest rate at their invoice amounts without discounting, if the effect of discounting is immaterial.
- The amendments to AASB 116 and AASB 138 remove perceived inconsistencies in the accounting for accumulated depreciation/amortisation when an item of property, plant and equipment or an intangible asset

is revalued. The amended standards clarify that the gross carrying amount is adjusted in a manner consistent with the revaluation of the carrying amount of the asset and that accumulated depreciation/amortisation is the difference between the gross carrying amount and the carrying amount after taking into account accumulated impairment losses.

3. Significant Accounting Policies

Basis of Preparation

The financial report has been prepared on the basis of historical cost. Cost is based on the fair value of consideration given in exchange for assets. All amounts are presented in Australian dollars, unless otherwise stated.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the company takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these financial statements is determined on such a basis, except for leasing transactions that are within the scope of AASB 117.

The following significant accounting policies have been adopted in the preparation and presentation of the financial statements:

(a) Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned to inventory on hand by the method most appropriate to each particular class of inventory, with all classes of inventory being valued on a first in first out basis. Net realisable value represents the estimated selling price less all estimated costs of completion and costs necessary to make the sale.

(b) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

Property

Buildings, plant and equipment are stated at cost less accumulated depreciation and impairment. Costs include expenditure that is directly attributable to the acquisition of the item. In the event that settlement of all or part of the expenditure is deferred, cost is determined by discounting the amounts payable in the future to their present value as at the date of acquisition.

Plant and Equipment

Depreciation is provided on property, plant and equipment, including freehold buildings but excluding land. Depreciation is calculated on a straight line basis so as to write off the net cost or other revalued amount of each asset over its expected useful life to its estimated residual value from the time the asset is held ready for use. The estimated useful lives, residual values and depreciation method are reviewed at the end of each annual reporting period, with the effect of any changes recognised on a prospective basis.

(c) Income Tax

An income tax liability has not been raised as the Club's activities make its income exempt from tax pursuant to the Income Tax Assessment Act.

(d) Trade & Other Receivables

Trade and other receivables are stated at cost less impairment losses. The average credit period on sale of goods and rendering of services is 30 days. Credit balances on members' accounts are applied to futures charges, or refunded to relevant members as appropriate.

In determining the recoverability of a trade receivable, the Club considers any change in the credit quality of the trade receivable from the date credit was initially granted up to the reporting date. Based on historic default rates, the Club believes that no impairment allowance is necessary in respect of trade receivables.

(e) Trade & Other Payables

Trade and other payables (including accrued expenses) represents liabilities for goods and services provided prior to the end of the financial year and which are unpaid. The amounts are unsecured, and are paid within normal supplier trading terms, but usually no longer than 30 days.

(f) Employee Benefits

A liability is recognised for employee entitlements arising from services rendered by employees to reporting date, when it is probable that settlement will be required and they are capable of being measured reliably. Employee entitlements expected to be settled within one year together with entitlements arising from wages and salaries, and annual leave which will be settled within 12 months, have been measured at their nominal values using the remuneration rate expected to apply at the time of settlement. Liabilities recognised in respect of employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the Club in respect of services provided by employees up to reporting date. Contributions are made by the Club to employee superannuation funds and are charged as expenses when incurred.

(g) Cash & Cash Equivalents

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(h) Revenue

Revenue is measured at the fair value of the consideration received or receivable. Revenue from membership subscriptions is recognised upon the renewal date of the subscription. Entrance Fees are recognised as revenue when received. Revenue from the sale of goods is recognised upon delivery of goods to customers.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets. Dividend revenue from investments is recognised when the shareholder's right to receive payment has been established.

(i) Goods & Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST) except:

- Where the amount of GST incurred is not recoverable from the taxation authority, it is recognised as part of the cost of acquisition of an asset or as part of an item of expense or;
- For receivables and payables which are recognised inclusive of GST.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables.

3. Significant Accounting Policies (cont.)

(j) Impairment of Tangible Assets

At each reporting date, the Club reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Recoverable amount is the higher of fair value less costs to sell and value in use. In respect of not-for-profit entities, where the future economic benefits of an asset is not primarily dependent on the assets' ability to generate net cash inflows and where the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciable replacement cost of an asset less, where applicable, accumulated depreciation calculated on the basis of such cost to reflect the already consumed or expired future economic benefits of the asset.

The current replacement cost of an asset is its cost measured by reference to the lowest cost at which the gross future economic benefits of that asset could currently be obtained in the normal course of business.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at fair value, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised in profit or loss immediately.

(k) Financial Assets

Financial assets are stated at cost at balance date, with any resultant gain or loss recognised in profit or loss. The net gain or loss recognised in profit or loss excludes any dividend or interest earned on the financial asset. Fair value is determined with reference to quoted market prices.

(I) Working Capital

Member's subscriptions received in advance amount to \$1,843,944 (2014: \$1,657,236) and are recognised in this financial report as a liability as the revenue relates to the year ending 30 June 2015. The consequence of this treatment is a net working capital deficiency of \$544,285 (2014: net deficit \$616,892). This liability will be transferred to revenue in the following financial year ending 30 June 2016 thereby restoring the Club's working capital position.

(m) Critical Accounting Judgments & Key Sources of Estimation Uncertainty

In the application of the Company's accounting policies, management is required to make judgments, estimates and assumptions about carrying values of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods. Judgements and estimates made by management in the application of the Company's accounting policies are disclosed where applicable, in the relevant notes to the financial statements.

(a) Market Risk

The Club's activities expose it primarily to the financial risks of changes in interest rates (refer to note 20(c)). There has been no change in the Club's exposure to market risk in which it manages and measures the risk from previous periods.

(b) Interest Rate Risk Management

The Club is exposed to interest rate risk on cash and cash equivalents. The Club's exposure to interest rates on financial assets is detailed in the liquidity risk management section of this note.

(c) Interest Rate Sensitivity Analysis

Interest rate sensitivity analysis have been determined based on the exposure to interest rates at the reporting date and the stipulated change taking place at the beginning of the financial year and held constant throughout the reporting period. At reporting date, if interest rates had been 50 basis points higher or lower and all other variables were held constant, the Club's net loss would decrease\increase by \$9,070 (2014: net loss would decrease \ increase by \$7,773).

(d) Credit Risk Exposures

The maximum exposure to credit risk, excluding the value of any collateral or other security, at balance date to recognise financial assets is the carrying amount of those assets, net of any provisions for doubtful debts, are as disclosed in this report.

(e) Fair Value of Financial Instruments

For financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

There are no financial assets or liabilities that are measured at fair value. The Directors consider that the carrying value of financial assets and financial liabilities recognised approximate their fair values.

20. Financial Instruments (cont.)

The Club derives a large portion of its revenues from annual subscriptions and entrance fees. Members have the option to accept deferred payment arrangements for subscriptions and entrance fees in line with the Club's membership policies.

Where members do not pay subscriptions and entrance fees in line with the Club's policies, membership may be suspended or withdrawn. Historically, the Club has a very low default rate on the receipt of subscriptions and entrance fees from members electing to take deferred payments terms.

The Club's financial instruments are held with the ANZ Bank and ANZ Trustees.

(f) Liquidity and interest rate risk tables

Ultimate responsibility for liquidity risk management rests with the Committee members, who have built an appropriate liquidity risk management framework for the management of the Club's liquidity management requirements. The Club manages liquidity risk by maintaining sufficient cash balances.
