PROXIES

A Member entitled to attend and vote at a meeting of the Club is entitled to appoint a person, including the chairperson, as proxy to attend and vote instead of that Member. The proxy form is available from the administration office of the Club and should be lodged at that office by 5pm on Tuesday, 14 November 2017.

Restricted Playing Members, Non Playing Members (other than Special Non Playing Members), House Members, Junior Members, Temporary Members, Honorary Members and Absentee Members are not entitled to vote or to appoint proxies.

CANDIDATES FOR OFFICE

The names of all candidates for office, together with the names of their proposers and seconders, must be in the hands of the Honorary Secretary at least 30 days before the Annual General Meeting. Each nomination must be in writing and, where practicable, be accompanied by the written consent of the candidate. Should a ballot be necessary, because the number of candidates exceeds the number of vacancies, the Honorary Secretary will forward before the date of the elections, a Ballot Paper by post to every Member entitled to vote.

NOTICE OF PROPOSED RESOLUTIONS

NOTES

This notice is enclosed with, and forms part of, the Notice of Annual General Meeting dated 26 September 2017.

This notice sets out special resolutions to be considered under Agenda item 2 and, if thought fit, to be passed as special resolutions at the Annual General Meeting of Members of the Club to be held in the clubhouse at 7.30 pm on Thursday 16 November 2017.

The Explanatory Notes do not form part of the resolutions to which they relate.

Annual General Meeting continued

SPECIAL RESOLUTIONS

i) To consider and if thought fit, to pass the following resolution as a special resolution:

That the Constitution be amended by deleting the current Clause 11.1 and replacing it with the new Clause 11.1 as follows:

11.1 The Committee

Unless the Club in General Meeting otherwise resolves, the Committee, effective from the date of the 2018 Annual General Meeting, will comprise nine Committee Members and be constituted as follows:

- a) the five Honorary Officers
- b) four other Voting Members

Explanatory Note: As presently drawn, the Constitution provides for six members of the Committee in addition to a President, Vice-President, Captain, Honorary Treasurer and Honorary Secretary. It also allows for the Immediate Past President to remain on the Committee after leaving the office of President.

The proposed special resolution (and the proposed amendment of Clauses 1.1 and 11.6 below) would have the effect of reducing the number of "other Voting Members" of the Committee from six to four and removing the Immediate Past President from the Committee. Therefore, the total number of Committee members would be reduced from twelve to nine.

It is intended that this change would take effect from the 2018 Annual General Meeting.

This change is being made in accordance with "RSY Towards 2020 Strategic Plan" and the key desired outcome of strengthening best practice corporate governance by streamlining and refining the Committee and its roles.

ii) The following Constitution changes are incidental changes required as a result of the change to Clause 11.1.

To consider and if thought fit, to pass the following resolution as a special resolution:

That the Constitution be amended by deleting the current definitions of Committee Member and Committee Position in Clause 1.1 and replacing it with the new definitions of Committee Member and Committee Position as follows:

1. GENERAL

1.1 Definitions

Committee Member means a Voting Member appointed or elected to the Committee in accordance with this Constitution, and includes Honorary Officers.

Committee Position means the Office or position of President, Vice-President, Captain, Honorary Treasurer, Honorary Secretary or Committee Member (being a Committee Member other than an Honorary Officer).

Explanatory Note: As presently drawn, the definition of a Committee Members includes the Immediate Past President and the definition of a Committee Position refers to the position of Immediate Past President. These incidental changes will remove the references to the Immediate Past President, as a result of the removal of this position from the Committee in the changes proposed to Clause 11.1 above.

It is intended that this change would take effect from the 2018 Annual General Meeting.

iii) The following Constitution change is an incidental change required as a result of the change to Clause 11.1.

To consider and if thought fit, to pass the following resolution as a special resolution:

That the Constitution be amended by deleting the current Clause 11.6 and replacing it with the new Clause 11.6 as follows:

11.6 Retirement of Committee Members

- a) Subject to the Act and this Constitution (including paragraph (c) of this clause), a Committee Member holds office until the end of the second Annual General Meeting following that Committee Member's election or until he or she vacates office, whichever is the sooner.
- b) A Committee Member appointed to a Committee Position under sub-clause 11.5 retires from office at the end of the first Annual General Meeting following such appointment.
- c) At every Annual General Meeting not less than four Committee Members must retire from office and are eligible for election or re-election.
- d) If at an Annual General Meeting, the number of Committee Members retiring in accordance with sub-paragraphs (b) and (c) is less than four, the Committee must decide, by agreement or, if there be no agreement, by lot conducted by the Committee, which other Committee Members retire in order that at least four Committee Members retire.

Explanatory Note: As presently drawn, the current Clause 11.6(a) refers to the term of Office for the position of Immediate Past President. These incidental changes will remove the current clause 11.6(a) and therefore reference to the term of Office of the Immediate Past President as a result of the removal of this position from the Committee in the changes proposed to Clause 11.1 above. Given the proposed change in Committee numbers, clause (c) and (d) have been altered to reflect the retirement of not less than four Committee Members on an annual basis rather than five as currently required.

It is intended that this change would take effect from the 2018 Annual General Meeting. iv) The following Constitution change is an incidental change required as a result of the change to Clause 11.1 and the fact that the change to Clause 11.1 (and the other incidental changes) will not take effect until the 2018 Annual General Meeting.

To consider and if thought fit, to pass the following resolution as a special resolution:

That the Constitution be amended by adding the new Clause 11.10 as follows:

11.10 2017 Transitional Provision

The amendments to the following Clauses, as shown with 'track changes' in this Constitution which were approved at the 2017 Annual General Meeting will only take effect from the 2018 Annual General Meeting:

- a) the definitions of 'Committee Member' and 'Committee Position' in Clause 1.1;
- b) Clause 11.1; and
- c) Clause 11.6.

Explanatory Note: This change is required to make it clear that the changes to Clauses 1.1, 11.1 and 11.6 described above will only take effect from the 2018 Annual General Meeting. A copy of the Constitution showing the tracked changes referred to above is available on the Club website or from the office.

This change would take effect upon this resolution (iv) being passed (i.e. immediately).

Report of the Committee

To the Members, Royal South Yarra Lawn Tennis Club

The Committee presents the accounts of the Club for the year ended 30 June 2017, and reports to you on the affairs of the Club for this period.

The General Committee remained unchanged from the previous year. Your Committee have continued to work constructively towards achieving the key undertakings of the "RSY Towards 2020" Strategic Plan and the "RSY Pathway to Excellence" visions.

FINANCE

The financial position and performance of the Club is detailed within the Treasurers Report. Results for the year were an operating loss of \$284,813 (2016: loss \$17,391). Cash flows from operating activities were \$450,504 (2016: \$259,261). Capital expenditure of \$386,645 (2016: \$390,282) was invested in Property, Plant and Equipment and Club Amenities.

Hospitality Revenues were slightly lower at \$2,858,764 (2016: \$2,953,963) due to declining member and visitor activity. Staff costs in this important service area were significantly higher than the previous year. This expense line has, and will continue to be, addressed by our new senior management team.

PROPERTY AND ASSETS

The Club has been working on a plan for a staged Grounds Redevelopment program.

Whilst a significant amount of funds has been invested into the clubhouse and accommodation in recent years, it is fair to say that very little has been invested into the courts and surrounds above and beyond annual maintenance.

Some detailed concept plans have been prepared for "Stage 1" of the Grounds Redevelopment Plan and it is our intention to disseminate this information to the wider membership shortly, once we have finalised anticipated costs and budgets.

Over the past 12 months we have completed the refurbishment of the Billiards Room and Squash courts as well as started works on the Pavilion, continued the LED lighting replacement program and undertaken court resurfacing.

Key focuses for 2017/18 will be:

- Presentation of the Grounds Redevelopment Plans to Members in the first quarter 2018 with commencement in mid-2018.
- Ongoing courts resurfacing.
- Further investigation around POA (winter grass) control and optimum grass species for the courts.

POA annual (winter grass) control is the single biggest issue facing the Australian turf industry and we have certainly not been immune to this at Royal South Yarra. The major problem is centred around turf resistance to current chemicals available and we are experiencing more winter grass at Royal South Yarra than in previous years which does impact on the quality of the grass surfaces.

We have recently engaged an expert turf consultant to assist our grounds team to ensure we deliver the best courts possible in the upcoming grass court season and more importantly, into the future.

MEMBERSHIP

The Committee is close to finalising the simplification and digitisation of the Member nomination process. Online editable versions of nomination forms will be available on the Club website very soon as a key outcome of this review process. Hard copies will continue to be available from the office.

The process for new Member approvals has also been altered and all Members (rather than a panel of Members) will now be advised via email and on the Club noticeboards of all applicants seeking election to membership.

Key focuses for 2017/18 will be on:

- Reviewing the current membership categories and the rules and procedures around membership.
- Looking at a variety of membership strategies to attract new Members and retain current Members in this challenging membership environment.
- Reviewing the Member induction process.

SPORTING ACTIVITIES

The Club continues to actively participate in elite Victorian tennis competitions.

We have had a very successful 2016/17 in tennis competitions which is detailed in the Sports Report.

The Club has now completed the installation of LED lighting to all en-tout-cas courts. Grass courts 3 and 4 have been resurfaced and we look forward to the opening of these newly surfaced courts towards Christmas.

The Club has also recently completed a significant renovation of the squash courts which has enhanced the player and spectator experience in this area.

Key focuses for 2017/18 will be on:

- Improving the quality of the grass courts and controlling the POA (winter grass).
- Continuing to investigate opportunities for new sporting options and facilities.

Report of the Committee continued

IT AND COMMUNICATIONS

The Club continues to investigate an upgrade of its technology applications aimed at improving member services and operational procedures. The key area addressed in this past year is increasing traffic to the Club website and our social media platforms (Facebook, Instagram, Twitter, You Tube).

We have also undertaken an extensive review of our Member communication and the readership numbers for "Happenings" continue to go from strength to strength. A new format for this important publication is close to finalisation.

Internally, we have also created an internal staff communication system which has improved the dissemination of information to our staff.

Key focuses for 2017/18

- We have also been undertaking a review of our reservation systems and are about to release a new online platform for tennis court bookings 7 days a week from 6.00am to 10.00pm.
- Further investigation of online booking systems for functions and accommodation.
- Improving our administration systems and collection of business intelligence data.

GOVERNANCE

As you are all aware, former General Manager, Kim Young resigned in November 2016. The Club subsequently went through an extensive recruitment process which resulted in our new Chief Executive Officer, Stewart Fenton commencing in June 2017.

During this period our Director of Finance, Tim Juusti was appointed into an Acting General Manager position. I would like to take this opportunity to thank Tim for the outstanding job and significant contribution he made through this period.

Stewart's role has been titled CEO and this was an important step for the Club in our ongoing efforts to transition operational authority and responsibilities from the General Committee to management, which is a key initiative from the Strategic Plan, as we strengthen our best practice corporate governance practices.

There has been much discussion about corporate governance in society in recent years, particularly in Clubs and it is imperative that as a membership we understand that we employ professionals to run the Club and it is vitally important that our Committee structure, practices and processes allow them to do this in relation to day to day operational running of the Club. The Committee's responsibilities rest around the strategic task of setting the organisation's strategic goals, direction, limitations and accountability and risk frameworks. One way to think about this is that governance determines the "What" – what the strategic direction of the organisation is and should be in the future. Management determines the "How" – how the organisation will reach those goals and aspirations. The analogy of steering versus rowing is another way of looking at this.

As part of the upcoming Annual General Meeting we are also seeking your support for a reduction in the General Committee size from 12 to 9. This again reflects the trend in strengthening corporate governance by having a more streamlined Committee structure that is strategically focused.

Key focuses for 2017/18

- Establishing clear charters for Sub-Committees and clearly defining roles and responsibilities.
- Development of a formal succession planning policy and process for the General Committee.
- Introducing a formal induction process for all new Committee members.

STAFF

There is no doubt we have a great team at Royal South Yarra who genuinely care about the needs of Members.

Under Stewart's leadership a number of staff changes have occurred in recent months as we seek to improve our operations and member service standards. We would like to thank those who have left for their efforts during their time at Royal South Yarra and we welcome our new staff to the team.

In particular, we would like to acknowledge the retirement of our long-standing Head Curator, Bill Turner. Bill diligently served the Club for almost 43 years and we would like to sincerely thank him for his efforts and contribution to the Club over this period.

The Committee would particularly like to thank our senior management team for their commitment and efforts to our great Club. They continue to serve our membership with great enthusiasm and they contribute significantly to our reputation as one of Australia's finest sporting clubs.

Key focuses for 2017/18

- To continue to grow our reputation as an employer of choice.
- To continue to support our staff through professional development opportunities.

Report of the Committee continued

EXTERNAL RELATIONS

We have continued the progress made in recent years in relation to strengthening our relationship with Tennis Victoria, Tennis Australia and Stonnington Council.

We have also worked hard on continuing to strengthen our relationship with our close friends at Kooyong, Royal Melbourne Tennis Club, West Brighton Club and the City Clubs. Over the course of the year we have hosted and attended many great functions and events conducted at these Clubs.

In the last financial year we introduced one new reciprocal club, the Edgbaston Priory Club in Edgbaston, Birmingham UK.

Many Members may not be aware but Royal South Yarra is a Member of the prestigious Centenary Tennis Clubs boasting some of the most prestigious and exclusive clubs in the world.

We continue to expand the list of like-minded reciprocal clubs which meet the standards of the Club's reciprocal club policy and we are always grateful for Member's feedback on clubs they have visited.

RSYLTC FOUNDATION

The Foundation has continued to grow and we thank all Members who have contributed to the Foundation for their support. The Foundation is a very important part of the Club and its future. A separate report on the work of the Foundation is included in the Annual Report and we thank Foundation Chairman, Derek Skues and his fellow Trustees for their significant contribution in administering the wonderful work that the Foundation undertakes.

We would ask all Members to consider donating to the Foundation (it is tax deductible through the Australian Sports Foundation) as all contributions to the Foundation are used to improve the Club's facilities for the benefit of all Members and in doing so secure the Club's future.

GENERAL

All the available data in Australia shows that membership based clubs are generally experiencing declining membership numbers as the population ages, with younger people not joining clubs like they used to.

The days of long waiting lists are gone and things are no different for Royal South Yarra and in fact most of the traditional private clubs.

As a Club we understand that many Members don't like or want things to change from the past but to remain relevant and to continue to prosper well into the future, the Club must continue to evolve and be proactive in addressing future challenges around membership, rising operational costs (and in particular areas like increasing water, gas and electricity costs), facilities and staffing (increasing costs and access to quality staff).

Membership is the lifeblood of the Club and historical membership data shows that over the past 10 years our membership has stayed largely stagnant with the number of resignations closely matching the number of new Members admitted year on year.

Whilst financially the annual entrance fee income achieved through this scenario is beneficial to the Club we know that membership is one of the key issues facing the Club over the next few years and a continued focus by the General Committee and management around refining and developing long term sustainable membership strategies not only around attracting new Members but also on membership retention, is of vital importance in ensuring the long-term survival of the Club.

All Members have an important role to play in bringing forward new applicants for membership. If just 10% of our membership bought forward one new applicant for membership each year the financial benefit for the Club would be significant with an additional \$585,000 in annual revenue (assuming they were adult members) and almost \$2 million in one off entrance fee income.

I would like to take this opportunity, my last as President of this great Club, to thank my fellow Directors for your efforts, support and friendship during not only my two years as President but throughout my time on the Committee. To the wider membership, thank you for your support and I am proud to be a Member of Royal South Yarra.

In closing can I say that I leave the role of President with the Club in very good hands going forward from an experienced and committed Committee and a very capable Executive management team and staff led by Stewart Fenton. We are in a very sound financial position but need to plan for the future. We need to understand the needs of our wider membership and plan to ensure that our facilities are world class to meet not only the needs of current Members but also in attracting new Members. We must strive to be the very best we can.

Sports

TENNIS

The past year has seen an increase in the use of the tennis and squash courts and record numbers of teams across several competitions. The Club entered teams in the Tennis Victoria Pennant and Premier League competitions. In the pennant competition, the Women's Grade 3 team won the premiership and the Women's Grade 2(1) finished runners-up. The Cub fielded a men's and women's team in the 2016 Premier League competition which is the highest competition in Victoria where players compete against the state's best tennis players.

Many Club Members attend country tournaments throughout the year including Kerang, Shepparton and Warrnambool. Country tournaments, usually played on quality grass courts, combine fierce but friendly on court rivalries with a laid-back country hospitality. A highlight for many Members at these country tournaments is the camaraderie shared by all Club members in attendance.

The Club provides Members with a range of opportunities to participate in all levels of competition and social tennis and other sporting, fitness and social activities. During the year the Captains Committee organised the RSY Sports Dinner, Croquet Tournament, Table Tennis Club Championships, President's Day, Royal Sydney Golf Club Visit, Tennis Club Championships, President's vs. Captain's Tennis Challenge, participation in Tennis Victoria tennis competitions and the Squash Club Championships.

PENNANT TENNIS

The Club entered 17 teams overall in the men's and women's 2016 Tennis Victoria Pennant competition. It was a successful year with the following men's and women's teams advancing to the grand finals – the Women's Grade 3 team consisting of Piper Priestley, Emily Collin, Stacey Flaounas, Sam Ritchie, Georgia Rogers (Captain), Ellie Rogers & Nikita Chumbley defeated MCC in the premiership. Membership Board

Member numbers at year end were 4,479 persons. There was an overall reduction of 9 members through death, resignation and forfeiture. On 1 July 2016, 53 junior members, on attaining 18 years of age, became eligible for senior Playing membership status, and 30 men, 46 women, 29 boys and 31 girls from the waiting list were elevated to Playing and Junior membership of the Club.

Treasurer's Report

The Club's financial position remains strong. Our Club has no debt, and we funded over \$386,000 in capital expenditure from operating cash flow during the financial year. After several years of improvement in our Profit and Loss position, our results in 2017 were less strong, and were well below our budget expectations.

OPERATING RESULT

The Club's loss for the year increased to \$285,000 from just under breakeven in financial year 2016.

Several factors influenced this outcome. Most notably, our losses from Hospitality (Bar and Dining) increased by almost \$200,000. Revenues were down by 3.2%, reflecting lower patronage levels. Tight control of COGS ensured that gross margin was acceptable, but our overhead expense levels were too high. Balancing strong service levels over extended opening hours with appropriate price points to deliver acceptable financial results is always a challenge. In the 2017 year we did not get this balance right, and considerable work and changes have been made in this area over recent months in conjunction with our new CEO.

Profits from Accommodation (our Mont Verdant apartments) also disappointed, down by one third, with revenues falling 3.2% due to much weaker occupancy levels, and utility and council rates well up. At a general level, the Club sought to lift standards for grounds and facilities, with a substantial increase in repair and maintenance expense, by over \$100,000 for the year. Membership revenues were also weaker than expected, with the increase in subscriptions of \$154,000 offset by a reduction in entrance fees.

CASH FLOW AND CAPITAL EXPENDITURE

Operating cash flow in 2017 benefitted from favourable timing of member subscriptions. The Club remains committed to improving the standard of our facilities and again invested heavily to this end. Major items included the LED lights for courts 5 to 7 \$40,953 (and pre-payments for LED's on courts 8 to 15 \$33,591), renovation of the Billiards Room \$39,167, a new AV system \$33,333, and initial redevelopment work for Grass courts 3 & 4 of \$21,590.

PRINCIPAL ACTIVITIES AND OBJECTIVES

During the financial year, the principal activities of the Club, which remained unchanged, were the provision of sporting and clubhouse facilities and member accommodation. The Club's focus is on the development of tennis and increased member participation. Interclub competitions, hotshots, round robins, social events and junior activity days aim to increase participation both short term and long term.

OPERATING RESULTS

Results for the year, were an operating loss of \$284,813 (2016: loss \$17,391)

REVIEW OF OPERATIONS

Hospitality Revenues were slightly lower at \$2,858,764 (2016: \$2,953,963) due to declining member and visitor activity. This report discloses that the cash flows from operating activities resulted in a net cash inflow of \$450,504 (2016: \$259,261) and cash of \$386,645 (2016: \$390,282) was invested in Property, Plant and Equipment and Intangible assets.

SIGNIFICANT CHANGES IN THE STATE OF AFFAIRS

Apart from the foregoing, no significant change in the Club's state of affairs occurred during the financial year.

SUBSEQUENT EVENTS

No matter or circumstance has arisen since the end of the financial year which has or may significantly affect the operations of the Club, the results of those operations or the state of affairs of the Club in future financial years.

DIVIDENDS

The Club's memorandum of association prohibits the payment of dividends.

FUTURE DEVELOPMENTS

No change in the operations of the Club is expected to occur which will, or may, affect the results of the Club in the next succeeding financial year.

MEMBER LIABILITY

The Club is a company limited by guarantee. If the Club is wound up, the Constitution states each member (all classes) is required to contribute a maximum of \$8.40 each towards meeting any outstanding liabilities of the Club. As at 30 June 2017, the number of members were 4,479 (2016: 4,488).

ENVIRONMENTAL ISSUES

The Club's operations are not regulated by any significant environmental regulation under a law of the Commonwealth of Australia or of any State or Territory.

1. GENERAL INFORMATION & STATEMENT OF COMPLIANCE

3. SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The financial report has been prepared on the basis of historical cost. Cost is based on the fair value of consideration given in exchange for assets. All amounts are presented in Australian dollars, unless otherwise stated.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the company takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these financial statements is determined on such a basis, except for leasing transactions that are within the scope of AASB 117.

The following significant accounting policies have been adopted in the preparation and presentation of the financial statements:

(a) Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned to inventory on hand by the method most appropriate to each particular class of inventory, with all classes of inventory being valued on a first in first out basis. Net realisable value represents the estimated selling price less all estimated costs of completion and costs necessary to make the sale.

(b) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

Property

Buildings, plant and equipment are stated at cost less accumulated depreciation and impairment. Costs include expenditure that is directly attributable to the acquisition of the item. In the event that settlement of all or part of the expenditure is deferred, cost is determined by discounting the amounts payable in the future to their present value as at the date of acquisition.

Plant and Equipment

Depreciation is provided on property, plant and equipment, including freehold buildings but excluding land. Depreciation is calculated on a straight line basis so as to write off the net cost or other revalued amount of each asset over its expected useful life to its estimated residual value from the time the asset is held ready for use. The estimated useful lives, residual values and depreciation method are reviewed at the end of each annual reporting period, with the effect of any changes recognised on a prospective basis.

Depreciation rates

The depreciation rates used for each class of depreciable assets compared to the rates used last financial year are:

(c) Income Tax

An income tax liability has not been raised as the Club's activities make its income exempt from tax pursuant to the *Income Tax Assessment Act*.

(d) Trade & Other Receivables

Trade and other receivables are stated at cost less impairment losses. The average credit period on sale of goods and rendering of services is 30 days. Credit balances on members' accounts are applied to future charges, or refunded to relevant members as appropriate.

In determining the recoverability of a trade receivable, the Club considers any change in the credit quality of the trade receivable from the date credit was initially granted up to the reporting date. Based on historic default rates, the Club believes that no impairment allowance is necessary in respect of trade receivables.

(e) Trade & Other Payables

Trade and other payables (including accrued expenses) represents liabilities for goods and services provided prior to the end of the financial year and which are unpaid and are measured at amortised cost. The amounts are unsecured, and are paid within normal supplier trading terms, but usually no longer than 30 days.

(f) Employee Benefits

A liability is recognised for employee entitlements arising from services rendered by employees to reporting date. when it is probable that settlement will be required and they are capable of being measured reliably. Employee entitlements expected to be settled within one year together with entitlements arising from wages and salaries which will be settled within 12 months, have been measured at their nominal values using the remuneration rate expected to apply at the time of settlement. Liabilities recognised in respect of employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the Club in respect of services provided by employees up to reporting date. Contributions are made by the Club to employee superannuation funds and are charged as expenses when incurred.

(g) Cash and cash equivalents

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(h) Revenue

Revenue is measured at the fair value of the consideration received or receivable. Revenue from membership subscriptions is recognised upon the renewal date of the subscription over the course of the membership period. Entrance Fees are recognised as revenue when received. Revenue from the sale of goods is recognised upon delivery of goods to customers.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets. Dividend revenue from investments is recognised when the shareholder's right to receive payment has been established.

(i) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST) except:

- Where the amount of GST incurred is not recoverable from the taxation authority, it is recognised as part of the cost of acquisition of an asset or as part of an item of expense or;
- For receivables and payables which are recognised inclusive of GST.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or pay.

(j) Impairment of tangible and intangible assets

At each reporting date, the Club reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Recoverable amount is the higher of fair value less costs to sell and value in use. In respect of not-for-profit entities, where the future economic benefits of an asset is not primarily dependent on the assets' ability to generate net cash inflows and where the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciable replacement cost of an asset less, where applicable, accumulated depreciation calculated on the basis of such cost to reflect the already consumed or expired future economic benefits of the asset.

The current replacement cost of an asset is its cost measured by reference to the lowest cost at which the gross future economic benefits of that asset could currently be obtained in the normal course of business. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at fair value, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognized for the asset in prior years. A reversal of an impairment loss is recognised in profit or loss immediately.

(k) Working Capital

Member's subscriptions received in advance amount to \$1,916,085 (2016: \$1,719,752) and are recognised in this financial report as a liability as the revenue relates to the year ending 30 June 2018. The consequence of this treatment is a net working capital deficiency of \$670,448 (2016: net deficit \$501,464). This liability will be transferred to revenue in the following financial year ending 30 June 2018 thereby restoring the Club's working capital position.

(I) Critical accounting judgments and key sources of estimation uncertainty

In the application of the Company's accounting policies, management is required to make judgments, estimates and assumptions about carrying values of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods. Judgements and estimates made by management in the application of the company's accounting policies are disclosed where applicable, in the relevant notes to the financial statements.

Property, plant and equipment

As described in note 3(b), the company reviews the estimated useful lives of property, plant and equipment at each reporting period. No changes to the useful lives were determined during the current year.

Employee entitlements

Management judgment is applied in determining the following key assumptions used in the calculation of employee provisions at reporting date:

- Future increases in salaries and wages;
- Future on cost rates; and
- Experience of employee departures and expected period of service.
