PROXIES

A Member entitled to attend and vote at a meeting of the Club is entitled to appoint a person, including the chairperson, as proxy to attend and vote instead of that Member. SPECIAL RESOLUTIONS

To consider and if thought fit, to pass the following resolutions as special resolutions:

Special Resolution 1:

That the Constitution be amended by:

- deleting the words 'and the Immediate Past President' from the definition of a Committee Member in clause 1.1;
- deleting the words 'but does not include the office or position of the Immediate Past President' from the definition of a Committee Member in clause 1.1;
- deleting the definition of 'Immediate Past President' in clause 1.1;
- deleting the reference to '12' Committee Members in clause
 11.1 and replacing it with '11' Committee Members and
 deleting paragraph (b) of clause
 11.1 to remove the words
 'the Immediate Past President';
- deleting clause 11.6(a); and
- deleting clause 11.9(a).

Explanatory Note:

As all Members are no doubt aware there has been a significant focus in recent years on governance requirements for not for profit organisations such as Royal South Yarra Lawn Tennis Club. All Committee Members of Royal South Yarra Lawn Tennis Club are Directors of a company and must at all times act in accordance with the requirements of the Corporations Law and other relevant Australian legislation, some of which, such as the Occupational Health and Safety Act, can expose those directors to personal liability.

Whilst the Immediate Past President will always have an important role to play in the Club as a source of information and advice for the current President and other Directors, the fact that the Immediate Past President holds a position on the Committee under the current Constitution creates an unnecessary and unacceptable source of legal exposure for the Immediate Past President, particular given the fact they do not attend any Committee meetings. These changes in the Constitution, to remove the requirement that the Immediate Past President be part of the Committee, will alleviate this legal exposure without diminishing the importance and role of the Immediate Past President.

Special Resolution 2:

That the Constitution be amended by deleting the current Clause 7.1(b) and replacing it with the following:

- (b) Each candidate for Membership (other than Junior Membership) must be:
 - (i) proposed in writing to the Committee by one Voting Member;
 - (ii) seconded in writing to the Committee by one Voting Member; and
 - (iii) sponsored in writing to the Committee by two Members as referees, neither of whom may be a Junior Member, Honorary Member, Temporary Member or Absentee Member
 - A candidate for Junior Membership must be:
 - (A)proposed in writing to the Committee by one Voting Member; and
 - (B) seconded in writing to the Committee by one Voting Member.

Explanatory Note:

A Junior Member is defined in Clause 1.1 as a Member aged less than 18 years who has not been elected to Adult Membership. The intention of this change is to make it is easier for young people, under 18 years of age to join the Club, particularly children of current Members, by removing the burden of finding four sponsors that meet the minimum time periods as Adult Members of the Club required to sponsor an application. A recent policy change around sponsor requirements now allows Proposers and Seconders of Junior Members to be family Members and this change aims to provide further support for family membership applications by simplifying the process for young candidates.

It should also be noted that under clause 7.2 of the Constitution all Junior Members on attaining the age of 18 years must be elected an Adult Member by the Committee and that these candidates will be circulated to the whole membership for approval 21 days in advance. This provides an additional safeguard to ensuring they are suitable candidates for membership.

ORDINARY RESOLUTION

To consider and if thought fit, to pass the following resolution as an ordinary resolution:

Ordinary Resolution 1:

In accordance with Clause 9.4 of the Constitution, the Committee is seeking your approval to resolve to make a call on Members of:

- (i) \$250 for each Adult Member of the Club;
- (ii) \$100 for Members aged between 19 and 30;
- (iii) No call for Junior Members 18 and under;
- (iv)No call for any Member who has made a contribution of \$275 or more to the Royal South Yarra Lawn Tennis Club Foundation since its inception; and
- (v) No call will be payable by a person elected as an Honorary Life Member, Honorary Member or Temporary Member in accordance with Clause 9.4(d).

Should this resolution be passed by the Members at General Meeting, the call will be payable by 31 January 2020. An invoice to this effect will be sent to all Members who are required to pay this call.

Explanatory Note:

The Club has undertaken a significant amount of work in relation to a staged Grounds Enhancement Program. The concept designs and vision were presented to Members over the course of a number of Member Information Meetings and focus group sessions in late 2018. The Member feedback was taken on board and final concept designs were subsequently put on display in the clubhouse in early February 2019. Since that time, we have continued to refine the plans as we work through town planning requirements with the City of Stonnington, South East Water and Melbourne Water.

The Grounds Enhancement Program represents a significant part of our long-term strategic vision, through a staged approach, to upgrade the courtside surrounds and general grounds into a world class courtside environment. Whilst we appreciate that not all Members use the tennis precinct, over the past 50 years a significant contribution has been made by all Members to a number of clubhouse upgrades and renovations with little spent on the courts and surrounds which are such an integral part of the Club. This project is also seen strategically as a strong attraction to new Members. Membership is the lifeblood of the Club and a strong flow of new Members will continue to ensure the financial sustainability of the Club long term and assist with keeping subscription fees down. The cost of this project has been budgeted (costed by a registered Quantity Surveyor) at \$2.5 million and Stage 1 will include a new entrance on Verdant Avenue; a new exterior boundary fence; a new central spine, new internal tennis court fencing and extensive landscaping down the side of Porous Courts 1-4; four new Har Tru courts (one of which is an additional court which many years ago was sitting where the existing maintenance shed is now); rebuilding of the grounds shed in the laneway (subject to final approvals); new seating and landscaping where the hedges currently are and a new pathway extending from Porous Court 5 up to the Pavilion to allow the safe passage of all within our boundaries.

The funds raised by this call (expected to be in the order of \$600,000) will be used to fund part of the capital cost of this Grounds Enhancement Project. The balance will be funded by a mix of current Foundation funds (approximately \$524,000) and a debt financing facility. Extensive financial due diligence has been undertaken on this project and debt repayments will be met from operations, particularly given we are in a period of very low interest rates and have the capacity to achieve a specialised debt facility with repayments linked to our unique cashflows.

Report of the Committee



Report of the Committee

To the Members of Royal South Yarra Lawn Tennis Club

The General Committee presents the accounts of the Club for the year ended 30 June 2019, and reports to you on the affairs of the Club for this period.

This year we have continued to build on the successes of last year as we bring the Grounds Enhancement Project planning closer to a start date.

Your Committee have continued to work constructively towards achieving the key undertakings of the "RSY Towards 2020" Strategic Plan and the "RSY Pathway to Excellence" visions.

The key achievements in 2018/19 were:

FINANCE

The financial position and performance of the Club is detailed within the Treasurers Report. We are pleased to report that the Club has again made a profit this year after depreciation. This continues our improved financial performance under the direction of our new executive management team. We have continued to see growing revenues, strict cost control and strong membership revenues, which is most pleasing.

Results for the year, were an operating profit of \$235,195, which included a non-recurring benefit relating to a refund for the 2014-2018 Fire Services Levy of \$96,645 which was obtained after Chief Executive Officer, Stewart Fenton, successfully obtained a reclassification of our rating under the Cultural and Recreational Lands Act (2018: profit \$141,085). This reclassification will have a significant year on year benefit to our Club moving forward. I should note that almost \$200,000 was reimbursed to other local private tennis clubs after this decision resulted in their reclassification as well. Cash flows from operating activities resulted in a net cash inflow of \$720,768 (2018: \$640,871) and cash of \$988,056 (2018: \$320,818) was invested in Property, Plant and Equipment and Club Amenities. This included the purchase of an additional unit in the white flats on the corner of Verdant Avenue and Glover Court, (which is an important strategic holding for the Club).

PROPERTY AND ASSETS

Last year we reported that the key focuses for the year ahead would continue to be the Grounds Enhancement Program and improving the grass court surfaces. We are pleased to again report that we have made significant headway into both of these key objectives over the past 12 months.

The Club has undertaken a significant amount of work in relation to a staged Grounds Enhancement Program. The concept designs and vision were presented to Members over the course of a number of Member Information Meetings and focus group sessions in late 2018. The Member feedback was taken on board and final concept designs were subsequently put on display in the clubhouse in early February 2019. Since that time, we have continued to refine the plans as we work through town planning requirements with the City of Stonnington and South East Water and Melbourne Water. I am pleased to report that planning for this project is close to finalisation and we anticipate a start date in late 2019, early 2020.

As part of this project we have made the decision to install four new Har Tru courts (current porous courts 5,6,7 and a new court 7A). Har Tru is a self-watering clay court and is seen by the Club as the future replacement option of choice for the existing porous courts. Har Tru uses significantly less water than porous courts and requires very little maintenance compared to a traditional porous court. Wimbledon installed 8 Har Tru courts in 2018 and our discussions with them in relation to these courts have been really positive. Most pleasing has been the support from the wider membership for the installation of this new court surface at the Club.

The Grounds Enhancement Program represents a significant part of our long-term strategic vision, through a staged approach, to upgrade the courtside surrounds and general grounds into a world class courtside environment. We are very confident that this project will be successfully delivered in the 2019/20 financial year. Stage 1 will include a new entrance on Verdant Avenue; a new exterior boundary fence; a new central spine, new internal tennis court fencing and extensive landscaping down the side of Porous Courts 1-4; four new Har Tru courts; rebuilding of the maintenance shed in the laneway (subject to final approvals); new seating and landscaping where the hedges currently are and a new pathway extending from Porous Court 5 up to the Pavilion to allow the safe passage of all within our boundaries.

Stage 2 will be looked at in late 2020 and will include further investigation of adding Australian Open specification hard courts and the use and landscaping of the area from the Pavilion to the Bruce Street fence.

The grass courts have been a major focus area over the past 12 months as we strive to return the grass courts to amongst the best in Australia. We have seen significant progress made in the 2018/19 financial year and have just enjoyed the longest grass court season on record with the courts open to late June 2019. The feedback on the condition of the grass courts has been very good and we are confident that the work that has been undertaken this past year will keep us in good stead for this season as we begin to fully realise the impact of the changes that have been made. We will again lay the baselines in late September / early October (instead of winter) and have the turf specifically selected and grown off site in Pakenham under controlled conditions, including being regularly cut down to meet our needs.

Last year we completely rebuilt grass courts 5 and 6. With the Grounds Enhancement Program starting in late 2019, early 2020 we will not do any grass court replacements this year, but will again aim to replace a minimum of 2 courts each year as part of our ongoing renovation and replacement programs in late 2020.

Report of the Committee continued

Over the past 12 months we have also completed a number of important maintenance tasks including upgrading the irrigation system, individual switching of lights on each court and beautifying the Pavilion and surrounds.

In relation to the clubhouse, this year a key focus has been on maintenance. The strengthening of our finances has allowed a significant 'catchup' in maintenance to occur. This has included the replacement of the ceiling in the Courtyard Bistro, extensive painting including the Williams Road entrance and Verdant Avenue entrance, the re-grouting of the pool surrounds and changerooms and new benchtops in the Level 2 toilets. We have also repaired and replaced a significant amount of furniture through the Club, with new chairs and tables in the internal balcony area and Presidents Bar. We are also undertaking some refurbishment in the bar area to allow better servicing and viewing for staff.

Key focuses for 2019/20 will be:

- Commencement of the Grounds Enhancement Project
- Continuing our grass court improvement program and grass court replacement program (at least 2 more grass courts will be levelled and resurfaced in 2020)
- New tables in the Courtyard Bistro
- Further investigation of furniture upgrades
- · Separating some areas to make them adult only spaces

MEMBERSHIP

Membership was a big focus area for the 2018/19 financial year. We had another strong year in membership with 231 new Members joining the Club. We finished the year with an overall increase in numbers of 45. This backed up last year's result where we had an overall increase of 28.

As reported last year to remain strong and to continue to prosper well into the future, the Club must continue to change and evolve and be proactive in addressing future challenges around membership.

Our new Strategic Membership Committee has continued to have a busy year as we review existing membership processes and policies. We have recently launched our new online membership application process (editable versions of the nomination forms) and the sending out of all new applications to the wider membership has been well received. Many Members have taken advantage of the flexible instalment options for payment of their subscriptions this year.

The membership changes supported at the 2018 Annual General Meeting have been well received, particularly for younger members and supporting family membership.

We have recently conducted an extensive membership survey. We had 1,079 Members complete the survey which is a significant achievement and there are some clear trends evident. The data will now be fully analysed and will provide important feedback to the General Committee and management as we refine and develop future strategy. I am very pleased to report that on the whole the feedback has been really positive with overall satisfaction across the membership at 8 out of 10 and the membership generally very supportive of where the Club is heading. A full report on the survey will be made available to the membership in due course.

As the lifeblood of the Club, membership will continue to be the most important issue facing the Club over the next few years and will be a continued focus of the General Committee and management around refining and developing long term sustainable membership strategies not only around attracting new Members but also on membership retention. This is of vital importance in ensuring the long-term survival of the Club.

Members have an important role to play in bringing forward suitable new applicants for membership whilst at all times being mindful of retaining our strong existing tennis culture and family membership values.

Key focuses for 2019/20 will be on:

- Annual review of the current membership categories and the rules and procedures around membership
- Continuing to look at a variety of membership strategies to attract new Members and retain current Members in this challenging membership environment
- Continual review of the Member induction process to ensure a seamless transition of new Members into the Club
- Finalising our analysis and reporting of the membership survey

SPORTING ACTIVITIES

The Club continues to actively participate in elite Victorian tennis competitions.

We have had a very successful 2018/19 in tennis competitions and other sports which is detailed in the Sports Report. The highlight of 2018 was winning the Men's Grade 1 and Women's Grade 5 Tennis Victoria pennant final. We had more teams participate than ever before with 22 Winter pennant teams and 12 night competition teams.

We also had 3 squash teams in the Squash Pennant competition. Our table tennis championships continue to go from strength to strength and have become one of the highlights of the year with strong family participation. Our snooker and billiard teams continue to compete in the VBSA City Clubs Circuit competitions.

Key focuses for 2019/20 will be on:

 Continuing to investigate opportunities for greater participation in sports

IT AND COMMUNICATIONS

The Club continues to investigate an upgrade of its technology applications aimed at improving Member services and operational procedures.

Whilst last year the focus was on improved communication, this year the General Committee have approved an upgrade to our membership and administration systems and a new integrated website.

This new system, called Northstar (which is already being used by many private exclusive clubs), will be launched in October / November 2019 and will significantly enhance the membership experience. Features include the capacity to undertake online bookings for the restaurants, function rooms, accommodation, courts and coaching and classes. It will also allow us to improve security through an upgrade to our card access system. The quality of our website will also be substantially improved through this upgrade.

Key focuses for 2019/20

- Introduction of our new membership and administration system
- Introduction of our new club website
- Continuing collection of business intelligence data to allow
 better information to support decision making
- Continuing roll out of automatic payments for monthly accounts and flexible payment options for annual subscriptions
- Improve security

GOVERNANCE

As we reported last year, the appointment of our CEO was an important step for the Club in our ongoing efforts to transition operational authority and responsibilities from the General Committee to management as we strengthen our best practice corporate governance practices.

We have recently conducted a complete review of our Towards 2020 Strategic Plan. We are pleased to report that all key objectives from the plan have already been achieved. We will look towards a new Strategic Plan for 2020 and beyond in the near future.

As a Board we have reviewed many aspects of our performance and looked at how the General Committee can operate more effectively and efficiently. Our agenda for General Committee meetings has been overhauled to focus on key strategic decision making rather than on the operational detail. Reporting around key risk areas for Directors, such as Occupational Health and Safety, has been greatly enhanced and risk management planning has been a key focus.

- Development of a formal succession planning policy, a board skills matrix and a formal induction process for the General Committee
- Finalising our Risk Management plans
- Continuing to strengthen our best practice corporate governance practices
- Strategic Planning

STAFF

There is no doubt we have great staff who genuinely care about the needs of Members.

Under our Chief Executive Officer, Stewart Fenton's leadership many changes have occurred centred around improving the standards, particularly in the area of food and beverage. We continue to get good feedback on the changes that have been made and patronage and revenues in this important area continue to grow. The survey has provided some great feedback and enacting further change in this important area will be a continued focus of the Club.

The Committee would particularly like to thank our senior management team, under the leadership of our Executive Management team in Stewart Fenton (CEO), Tim Juusti (CFO) and Jarrad Wright (COO), for their commitment and efforts to continually improve our great Club. It has been another big year for the Club, and it is appropriate to acknowledge our senior management team individually for what has been achieved in the past 12 months - Anthony Lewis (Head Curator), Jake Ward (Executive Chef), Meagan Spicer (Administration and Sports Manager), Robyn Baker (Membership Manager), Samantha Dove (Functions and Events Manager), Joshua Burns (Director of Hospitality), Alex Morosan and Fiona Lucas (Hospitality Managers) and Greg Ward (Bar Manager). All of our staff continue to serve our membership with great enthusiasm, and they contribute significantly to our reputation as one of Australia's finest sporting clubs. I would also like to take this opportunity to thank all of our tennis coaches from SMARTennis, headed by Andrew McLean and Conrad Lim. SMARTennis play a valuable role in supporting both senior and junior tennis events and initiatives at the Club.

- To continue to grow our reputation as an employer of choice
- To continue to support our staff through professional development opportunities

EXTERNAL RELATIONS

We have continued the progress made in recent years in relation to strengthening our relationship with Tennis Victoria, Tennis Australia and the City of Stonnington.

We have a very strong relationship with Tennis Victoria and Tennis Australia. We have very much appreciated the ongoing support we have had in relation to our Grounds Enhancement Program, where both have provided significant advice and support.

We continue to strengthen our relationship with our close friends at Kooyong Lawn Tennis Club, Royal Melbourne Tennis Club, Royal Melbourne Golf Club, West Brighton Club and the City Clubs. Over the course of the year we have hosted and attended many great functions and events conducted at these Clubs.

During the year we announced a formal relationship around dining with Royal Melbourne Golf Club. We are aiming to have both a tennis and golf challenge with Royal Melbourne over summer as we continue to build on this relationship.

Many Members may not be aware that RSYLTC is a Member of the prestigious Centenary Tennis Clubs boasting some of the most prestigious and exclusive clubs in the world. This list expands regularly and is available from the Club administration office or from the website.

RSYLTC FOUNDATION

The Foundation has been very active over the past 12 months and we thank all Members who have contributed to the Foundation for their support. The Foundation is a very important part of the Club and its future. A separate report on the work of the Foundation is included in the Annual Report and we thank Foundation Chairman, Derek Skues and his fellow Trustees for their significant contribution in administering the wonderful work that the Foundation undertakes.

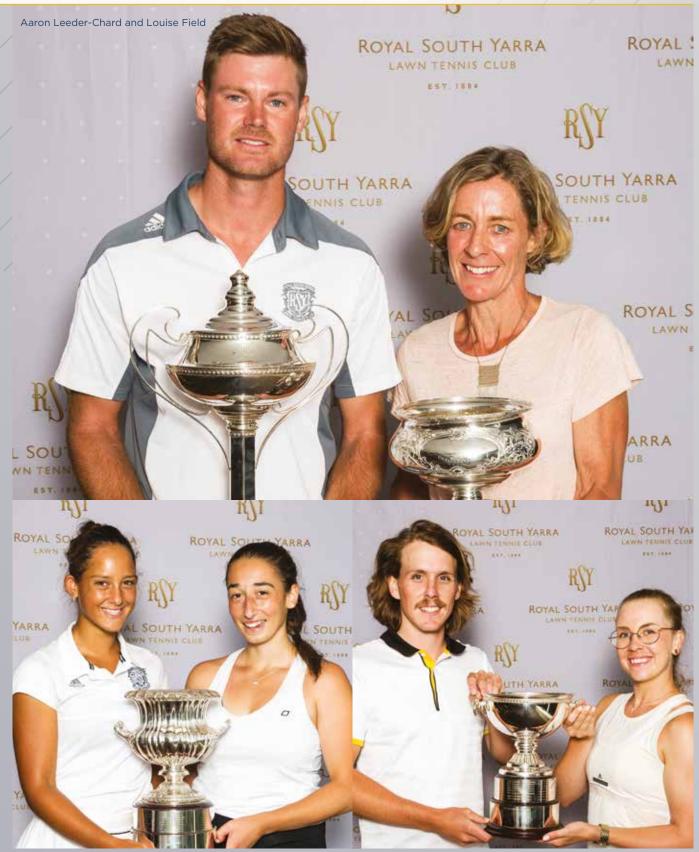

During the financial year the Bridge Group donated \$870 to Dementia Australia, \$340 to the Domestic Violence Resource Centre, \$340 to Make a Wish Foundation, \$340 to the RSPCA, \$2,000 to the RSY Grounds Enhancement Program and \$1,000 to the RSYLTC Foundation.

The Archives have a number of photographic folders extending back many years. There are some fantastic photos of past Club events as well as trophy and match winners.

ANNUAL REPORT 2019 Financial Statements 30 June 2019



Treasurer's Report

FY2019 can be characterised as a year of consolidation for the Club. Following sharply improved results in FY2018, our operating profit was broadly steady. A key factor was heavy reinvestment in both repair and maintenance expenses and in capital expenditure, all of which are required to further improve member services and the quality of Club facilities.

OPERATING RESULT

The Club's FY2019 operating profit (prior to non-recurring revenue) was \$138,550, continuing last year's very substantial improvement from the previous year's results. Including a non-recurring revenue item, pre-tax profit was \$235,195.

Club revenues increased by 4.6%, with all business segments achieving growth. Costs were well managed, with total operating costs increasing by 4.7%. Over 60% of this cost increase reflected a further significant investment in Repairs & Maintenance expense, which rose by 72% to over \$520,000. A key element of this is our new Club website and member management systems. This system will go live in October-November 2019 and is expected to greatly improve service delivery standards to Members. Other items on this line included re-grouting of the pool, exterior and interior painting, some furniture repairs and replacements, and installation costs for and some ceiling works in the clubhouse.

Hospitality revenues increased by 2% and COGS gross margin was on budget again at 40%, but the Club's loss in this department was broadly unchanged in FY2019, at (\$376,000). The Club did achieve a 26% reduction in losses in FY2018, but further structural improvement in Bar and Dining operations during FY2019 has not improved the bottom line. We have reported extensively in the past on some of the issues impacting results in Hospitality. The Club's philosophy is to continue to maintain a high-quality food and beverage offering as a service to Members, rather than trying to drive profits per se. Balancing strong service levels over very extended opening hours and delivering appropriate price points with acceptable financial results remains our key challenge. Despite rigorous and ongoing management focus, utilisation (patronage) levels remain the key variable, and we again implore Members to book in advance wherever possible, to assist the Club to efficiently manage the balance between staffing levels and labour cost.

Accommodation (Mont Verdant apartments) revenue increased by 21% in FY2019, driven by a 33% increase in the average occupancy rate (to 68%). Overhead costs also increased, with higher land tax and laundry expenses, resulting in a profit that was 5% ahead of last year.

CASH FLOW AND CAPITAL EXPENDITURE

Operating cash flow in FY2019 improved by \$80,000 to \$720,000, reflecting higher overall profits and favourable movement in receivables balances. The Club remains committed to improving the standard of our facilities, and to investigating future strategic growth options, and in FY2019 funded triple the usual levels of capital expenditure, at just under \$1m. This included the strategic purchase of another of the "white flats" at 3 Verdant Avenue, which was part-funded by borrowings of \$300,000, and which has been arranged on a basis expected to be cash flow-neutral. Other major capital items included the new Condensing Boiler units (\$63,000) for the pool and various grass court items: rebuild of courts 5 and 6 (\$54,000), a new Roller unit (\$33,000), and new netting (\$30,000). New individual light switches (\$15,000) were also installed on all courts.

PRINCIPAL ACTIVITIES AND OBJECTIVES

The principal activities of the Club were the provision of sporting, hospitality and clubhouse facilities and member accommodation. The Club's focus is on the development of tennis and increased member participation in all Club activities.

OPERATING RESULT

The total surplus for the year was \$235,195 which included non-recurring benefit relating to the refund of the 2014-2018 Fire Service Levy of \$96,645, resulting in an operating profit of \$138,550 (2018: profit \$141,085)

REVIEW OF OPERATIONS

Club sales revenue increased by 4.6%, with all business segments achieving growth. Costs were managed effectively, with total operating costs up by 4.7%. This increase in operating costs primarily relates to substantial reinvestment in Repairs & Maintenance approved by the General Committee including, amongst other things, re-grouting of the pool, exterior and interior painting of key elements of the Club, furniture repairs and replacements, installation costs for our new website and member management system (to launch October-November 2019) and some ceiling works in the clubhouse. Cash flows from operating activities resulted in a net cash inflow of \$720,768 (2018: \$640,871) and cash of \$988,056 (2018: \$320,818) was invested in Property, Plant and Equipment.

SIGNIFICANT CHANGES IN THE STATE OF AFFAIRS

Apart from the foregoing, no significant change in the Club's state of affairs occurred during the financial year.

SUBSEQUENT EVENTS

No matter or circumstance has arisen since the end of the financial year which has or may significantly affect the operations of the Club, the results of those operations or the state of affairs of the Club in future financial years.

DIVIDENDS

The Club's Memorandum of Association prohibits the payment of dividends.

FUTURE DEVELOPMENTS

No change in the operations of the Club is expected to occur which will, or may, affect the results of the Club in the next succeeding financial year.

MEMBER LIABILITY

The Club is a company limited by guarantee. If the Club is wound up, the Articles of Association state each member (all classes) is required to contribute a maximum of \$8.40 each towards meeting any outstanding liabilities of the Club. As at 30 June 2019, the number of members were 4,552 (2018: 4,507).

ENVIRONMENTAL ISSUES

The Club's operations are not regulated by any significant environmental regulation under a law of the Commonwealth of Australia or of any State or Territory.

1. GENERAL INFORMATION & STATEMENT OF COMPLIANCE

Financial reporting framework

The Club is not a reporting entity because in the opinion of the Committee there are unlikely to exist users of the financial report who are unable to command the preparation of reports tailored so as to satisfy specifically all of their information needs. Accordingly, this special purpose financial report has been prepared to satisfy the Committees' reporting requirements under the *Corporations Act 2001.*

For the purposes of preparing the financial statements, the Club is a not-for-profit entity.

Statement of compliance

The financial report has been prepared in accordance with the *Corporations Act 2001*, the recognition and measurement requirements specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101 'Presentation of Financial Statements', AASB 107 'Statement of Cash Flows', AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors', and AASB 1054 'Australian Additional Disclosures'.

The financial report was authorised for issue by the Committee on 27 August 2019.

Royal South Yarra Lawn Tennis Club is a company limited by guarantee, incorporated and domiciled in Australia.

2. ADOPTION OF NEW AND REVISED ACCOUNTING STANDARDS

2.1 Amendments to Accounting Standards that are mandatorily effective for the current reporting period The Club has adopted all of the new and revised Standards and Interpretations issued by the Australian Accounting Standards Board (the AASB) that are relevant to their operations and effective for an accounting period that begins on or after 1 July 2018.

The Club does not expect any material impact from the application of the new standards with the exception of the following:

AASB 15 Revenue and AASB 1058 Income for Not-for-profit entities

AASB 15 was issued in December 2014 to replace AASB 118 Revenue. AASB 1058 which contains new income recognition requirements for not for profit entities via AASB 1058 Income of NFP entities, AASB 2016-8 NFP specific guidance in AASB 15 and AASB 2016-7 deferral of AASB 15 was issued in December 2016 and replaces AASB 1004 Contributions.

AASB 1058 shifts the focus from the current reciprocal/nonreciprocal basis of accounting for revenue to a basis of assessment that considers the enforceability of a contract and the specificity of performance obligations. The core principle of the new income recognition requirements is that where there is an 'enforceable' contract with a customer with 'sufficiently specific' performance obligations, income would be recognised when (or as) the performance obligations are satisfied under AASB 15. Should the transaction fall outside of the scope of AASB 15, then income would be recognised immediately under AASB 1058.

Upon initial evaluation, the key changes in the standards that impact revenue recognition relate to the entrance fees which were recognised upon receipt under AASB 118 Revenue. Management's preliminary assessment indicates that entrance fees will be required to be recognised as revenue over the average tenure of membership. Management continue to quantify the financial impact of this change.

3. SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The financial report has been prepared on the basis of historical cost. Cost is based on the fair value of consideration given in exchange for assets. All amounts are presented in Australian dollars, unless otherwise stated.

The following significant accounting policies have been adopted in the preparation and presentation of the financial statements:

a) Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned to inventory on hand by the method most appropriate to each particular class of inventory, with all classes of inventory being valued on a first in first out basis. Net realisable value represents the estimated selling price less all estimated costs of completion and costs necessary to make the sale.

b) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

Property

Buildings, plant and equipment are stated at cost less accumulated depreciation and impairment. Costs include expenditure that is directly attributable to the acquisition of the item. In the event that settlement of all or part of the expenditure is deferred, cost is determined by discounting the amounts payable in the future to their present value as at the date of acquisition.

Plant and Equipment

Depreciation is provided on property, plant and equipment, including freehold buildings but excluding land. Depreciation is calculated on a straight line basis so as to write off the net cost or other revalued amount of each asset over its expected useful life to its estimated residual value from the time the asset is held ready for use. The estimated useful lives, residual values and depreciation method are reviewed at the end of each annual reporting period, with the effect of any changes recognised on a prospective basis.

c) Income Tax

An income tax liability has not been raised as the Club's activities make its income exempt from tax pursuant to the *Income Tax Assessment Act*.

d) Trade & Other Receivables

Trade and other receivables are stated at cost less impairment losses. The average credit period on sale of goods and rendering of services is 30 days. Credit balances on members' accounts are applied to future charges or refunded to relevant members as appropriate.

In determining the recoverability of a trade receivable, the Club considers any change in the credit quality of the trade receivable from the date credit was initially granted up to the reporting date. Based on historic default rates, the Club believes that no impairment allowance is necessary in respect of trade receivables.

e) Trade & Other Payables

Trade and other payables (including accrued expenses) represents liabilities for goods and services provided prior to the end of the financial year and which are unpaid and are measured at amortised cost. The amounts are unsecured, and are paid within normal supplier trading terms, but usually no longer than 30 days.

f) Employee Benefits

A liability is recognised for employee entitlements arising from services rendered by employees to reporting date, when it is probable that settlement will be required, and they are capable of being measured reliably. Employee entitlements expected to be settled within one year together with entitlements arising from wages and salaries which will be settled within 12 months, have been measured at their nominal values using the remuneration rate expected to apply at the time of settlement. Liabilities recognised in respect of employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the Club in respect of services provided by employees up to reporting date. Contributions are made by the Club to employee superannuation funds and are charged as expenses when incurred.

g) Cash and cash equivalents

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

3. SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation CONT'D

h) Revenue

Revenue is measured at the fair value of the consideration received or receivable. Revenue from membership subscriptions is recognised upon the renewal date of the subscription over the course of the membership period. Entrance Fees are recognised as revenue when received. Revenue from the sale of goods is recognised upon delivery of goods to customers.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets. Dividend revenue from investments is recognised when the shareholder's right to receive payment has been established.

i) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST) except:

- Where the amount of GST incurred is not recoverable from the taxation authority, it is recognised as part of the cost of acquisition of an asset or as part of an item of expense or;
- For receivables and payables which are recognised inclusive of GST.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or pay

j) Impairment of tangible and intangible assets

At each reporting date, the Club reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Recoverable amount is the higher of fair value less costs to sell and value in use. In respect of not-for-profit entities, where the future economic benefits of an asset is not primarily dependent on the assets' ability to generate net cash inflows and where the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciable replacement cost of an asset less, where applicable, accumulated depreciation calculated on the basis of such cost to reflect the already consumed or expired future economic benefits of the asset.

The current replacement cost of an asset is its cost measured by reference to the lowest cost at which the gross future economic benefits of that asset could currently be obtained in the normal course of business.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at fair value, in which case the impairment loss is treated as a revaluation decrease. Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognized for the asset in prior years. A reversal of an impairment loss is recognised in profit or loss immediately.

k) Working Capital

Member's subscriptions received in advance as at 30 June 2019 amount to \$1,547,123 (2018: \$1,832,997) and are recognised in this financial report as a liability as these receipts relate to the year ending 30 June 2020. The consequence of this treatment is a net working capital deficiency of \$150,799 (2018: net deficit \$250,168). This liability will be transferred to revenue on the commencement of the following financial year ending 30 June 2020, thereby restoring the Club's working capital position.

Critical accounting judgments and key sources of estimation uncertainty

In the application of the Club's accounting policies, management is required to make judgments, estimates and assumptions about carrying values of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods. Judgements and estimates made by management in the application of the Club's accounting policies are disclosed where applicable, in the relevant notes to the financial statements.

Property, plant and equipment

As described in note 3(b), the Club reviews the estimated useful lives of property, plant and equipment at each reporting period. No changes to the useful lives were determined during the current year.

Employee entitlements

Management judgment is applied in determining the following key assumptions used in the calculation of employee provisions at reporting date:

- Future increases in salaries and wages;
- Future on cost rates; and
- Experience of employee departures and expected period of service.
